FREQUENTLY ASKED QUESTIONS



Q1: What is Bible Song Cross+Gen?

Bible Song is a Scripture-based system for cross+gen (cross generational) faith formation. The many teaching options in Bible Song Cross+Gen will help you create a life-giving ministry that brings people of all generations together in faith. The 75 Bible story themes make learning fun for all ages. Bible Song Cross+Gen will also help you connect church and home through FAITH5 Home Huddles.

Q2: What does it cost to use Bible Song Cross+Gen?

The annual membership fee for Bible Song Cross+Gen is \$249.95. This annual membership fee gives you access to one 15-theme set. You receive a data disc with lesson/theme files, a sign language DVD, one Bible Song journal, one 2-disc music CD set, plus online (downloadable) access to the 15 themes.

Q3: How long is the Bible Song Cross+Gen membership year?

Bible Song Cross+Gen membership follows the academic year, starting on September 1 and expiring on August 31 of the following calendar year. Please carefully read the Bible Song Cross+Gen Membership Terms and Conditions for more information about membership renewal and cancellation.

Q4: What if I want to add another 15-theme set to my membership?

You can add additional 15-theme sets to your membership at any time. Any 15-theme set ordered during the membership year becomes part of the same membership and expires on August 31. For example, if you order a 15-theme set in June for use in the first half of the academic year, the membership for that 15-theme set will expire on August 31 of the following calendar year. If you order a second 15-theme set in December for use in the second half of the academic year, the membership for that 15-theme set also expires on August 31 of the following calendar year.

Q5: How many themes do I need for one academic year?

Faith Inkubators recommends using Bible Song Cross+Gen in a system that devotes two weeks to each theme or lesson. Using Bible Song Cross+Gen in this type of system means one 15-theme set is usually plenty to fill the academic year. Please refer to the Bible Song Cross+Gen Manual for a more complete explanation of this type of system.

Q6: What are the Bible Song journals?

The Bible Song journals are an amazing tool to help families bring the story home, and develop the nightly habit of FAITH5 Home Huddles. Each journal is beautifully illustrated with the same cartoons seen each week at church. Journals also include space for families to record their FAITH5 highs & lows and prayers. And inside each journal chapter are secret codes called FINKlinks that access a world of free and fun online games and activities.

Q7: What if our budget doesn't allow for journals?

Invite parents to invest in this vibrant and fun family communication tool, removing it from the church budget. For the price of a pizza, they'll have a journal to record their daily highs, lows and prayers. Consider purchasing a few to pass around so people can flip through them. Then simply pass a clipboard for folks to sign up to order one. You can place your church's order online, or by using the printable journal order form.

Q8: Do I need a lot of training to use Bible Song Cross+Gen?

You already have the most important thing you will need; a sense of adventure and willingness to create something new that brings generations together and connects church to home. Bible Song Cross+Gen is your toolbox to build it. Beyond that, what will help you most is to be connected with others who are doing the same! 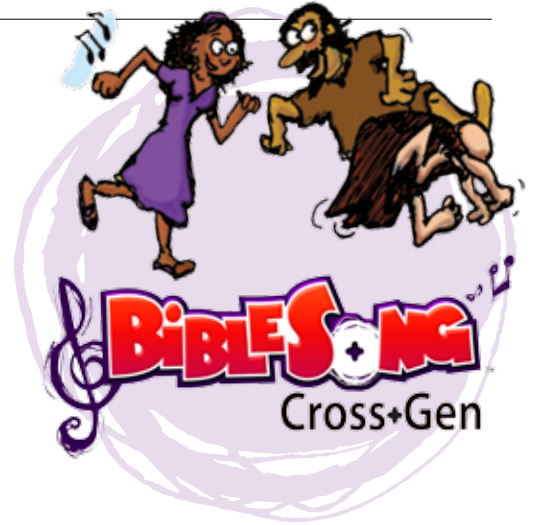
